It will happen like this—after her eighteenth birthday, she will be required to attend family weddings dressed in a sari, signaling her womanhood. Some nice Amma ("Aunty") will come and sit beside her, start asking questions and getting to know her: "How old are you? What's your family background? What does your father do? What universities are you applying to? What are your interests? When is your birthday?" Next thing you know, Tulsi's dad will get a big envelope in the mail with a photo of this woman's grandson who is studying computer sciences in Delhi, along with the boy's astrology charts and his university grades and the inevitable question, "Would your daughter care to marry him?"
